1. Mumbai Metro Rail Corporation (MMRC) has received a loan from Japan International Cooperation Agency (JICA) towards the cost of Project Mumbai Metro Line 3 (Colaba-Bandra-SEEPZ). It is intended that part of the proceeds of this loan will be applied to eligible payments under Contract for “Design, Manufacture, Supply, Installation, Testing & Commissioning of Rescue Vehicle (Rail-cum-Road Vehicle with Re-Railing & Rescue Equipment)” as per the Bidding Documents.
2. Bidding will be conducted through procedures in accordance with the applicable Guidelines for Procurement under Japanese ODA Loans and is open to all Bidders from eligible source countries, as defined in the Loan Agreement.
3. MMRC now invites sealed Bids from interested eligible Bidders for completion of “Design, Manufacture, Supply, Installation, Testing & Commissioning of Rescue Vehicle (Rail-cum-Road Vehicle with Re-Railing & Rescue Equipment)” as per the Bidding Documents. International Competitive Bidding will be conducted in accordance with JICA’s “**Single-Stage Two-Envelope Bidding**” procedure.

A complete set of the Bidding Documents may be purchased by interested Bidders on the submission of a written application to the address above and upon payment of a **non-refundable fee of INR 11,800 (Indian Rupees eleven thousand eight hundred only) inclusive of GST or USD 170 (US Dollars one hundred seventy only)** in the form of a demand draft in favour of Mumbai Metro Rail Corporation Ltd, payable at Mumbai **between 10 am to 5 pm from 20th Aug 2019 to 23rd Oct 2019.**
Alternatively, applicant can also download the Bidding Documents from the Website: www.mmrc.com. The applicants who have downloaded the Bidding Document, shall be solely responsible for checking the website for any addendum /amendment issued subsequently to the issue of Bidding Documents and take into consideration the same while preparing and submitting the bid proposal. The requisite non-refundable fee as mentioned above, in the form of a demand draft, in favour of Mumbai Metro Rail Corporation Ltd., payable at Mumbai, shall be submitted before or at the time of submission of Bids.
6. Pre-Bid meeting shall be held in MMRC office at the address mentioned in Sr No. 4 above **on 17th Sep 2019 at 11:30 am.**

Bids must be delivered to the address given above on or before **3 pm on 24th Oct 2019** and must be accompanied by a Bid security **of INR 10,00,000 (Indian Rupees Ten lakhs only) or USD 14,300 (USD Fourteen thousand three hundred only)** (as also indicated in ITB 21.1, Section II, BDS, Part 1).
