1. The Mumbai Metro Rail Corporation (MMRC) has received a loan from Japan International Cooperation Agency (JICA) towards the cost of Project 'Mumbai Metro Line 3 (Colaba-Bandra-SEEPZ)'. It is intended that part of the proceeds of this loan will be applied to eligible payments under Contracts for procurement of Depot Plant & Equipment including those listed in Para 3 below.
2. Bidding will be conducted through procedures in accordance with the applicable Guidelines for Procurement under Japanese ODA Loans, and is open to all Bidders from eligible source countries, as defined in the Loan Agreement.
3. The Mumbai Metro Rail Corporation (MMRC) invites sealed Bids from eligible Bidders for completion of **“Design, Manufacture, Supply, Installation, Testing & Commissioning”** of
 - A) Synchronized Under Floor Lifting System
 - B) Synchronized Mobile Lifting Jacks
 - C) Bogie Turn Tablesas per the Bid Documents.

International Competitive Bidding will be conducted in accordance with JICA's **“Single-Stage Two-Envelope Bidding”** procedure.

A complete set of the Bidding Documents may be purchased by interested Bidders on the submission of a written application to the address above and upon payment of a non-refundable fee of **INR 11,800 (Indian Rupees eleven thousand eight hundred only) inclusive of GST or USD 170 (US Dollars One hundred seventy only)** in the form of a demand draft in favour of Mumbai Metro Rail Corporation, payable at Mumbai between **10:00 hrs to 17:00 hrs from 5th Sep 2019 to 25th Nov 2019.**
Alternatively, applicant can also download the Bidding Documents from the Website: www.mmrc.com. The applicants who have downloaded the Bidding Document, shall be solely responsible for checking the website for any addendum /amendment issued subsequently to the issue of Bidding Documents and take into consideration the same while preparing and submitting the bid proposal. **The requisite non-refundable fee as mentioned above** in the form of a demand draft in favour of Mumbai Metro Rail Corporation Ltd., payable at Mumbai, shall be submitted at the time of submission of Bids.
6. Pre-bid meeting shall be held in at the address mentioned in sr. no. 4 above **on 24th Sep 2019 at 11.30 hrs.**
7. Bids must be delivered to the address given above on or before **15:00 hrs on 26th Nov 2019.** and must be accompanied by a Bid security of **INR 40,00,000/- (Indian Rupees Forty lakhs only) or USD 55000/- (US Dollars Fifty-five thousand only).**
